

**PROVISION OF SEVEN INTERNET CONNECTIONS OVER
EXISTING TELEPHONE LINES OF DGQA HQrs & ESTTS**

1. In terms of serial no. 20 of Financial Powers of DGQA issued vide MoD letter No. 63921/Delegation/DGQA/Adm/RMD/Budget/1798/D(QA) dated 25 Aug 2011, sanction of the Competent Financial Authority ie DGQA is hereby conveyed to incur an expenditure of Rs. 1,64,112/-(including GST @ 18% and one time charges) as initial expenditure towards installation of 07 Internet connection lines under Broad-band plans of **MTNL/BSNL only**. The list of sanctioned Internet connections alongwith details of expenditure per annum is enclosed as Appendix 'A'.
2. All Internet connections will be provided on separate stand alone computers earmarked for implementation of online APAR system (SPARROW) and will not be used for office work. The internet computer and communication line sockets will be kept separate for security purpose. The computer system will not be connected to any WAN/LAN.
3. Security instructions issued from time to time related to Computer Security & Cyber Security by Ministry of Home Affairs and Ministry of Defence will be strictly complied with by the establishments and requisite certificate/undertaking will be issued on monthly basis by the respective HOEs, who will be the Nodal officer for compliance of Departmental Security instructions
4. Format of the Initial Certificate to be duly signed by the respective HOEs enclosed as Appendix 'B' be forwarded directly to Director DGQA/SDCC, Room No. 2E,'G' Block, New Delhi for records under intimation to this HQ.
5. The expenditure involved is debitible to Major Head 2076, Minor Head 109C, (Sub Code Head 382/30) Misc Expenditure of the Defence Services Estimates.
6. This issues with the concurrence of IFA(MAP) vide their UO No. 091/IFA/MAP/2017-18 dated 25 Oct 2017.
