I am direc to convey the sanction of the President to the loan issue of one set of* unclassified or classified specifications drawings, as applicable by the establishment under the Directorate General Quality Assurance free of any charge, to trade firms against tender enquiries and supply orders projected by Defence organisations for the purpose of Promoting indigenous production of Defence stores. DRAWING . Rs. 120 - for each drawing bearing separate put No Cat No, In case the drawing has other related connected drawings Rs. 25'- mil be charged extra for each connected drawing.

2. I am also directed lo convoy the sanction of the President lo the loan issue of one set of unclassified or classified specifications 'drawings to the trade firms free of charge against limited lender enquiries and supply orders tor potty quantities (the number of approved suppliers will be restricted to a minimum of Six in each case) of stores required by Defence organisation for their own use. like gauges, test equipment or fixtures etc. The provisions of para 1 above with regard to the issue of one additional set. if the first set has been damaged and the charges hire charges lo be levied for the additional set will also be applicable in such cases.

- 3. Sanction of President is also convoyed to The supply of unclassified specifications' drwaing by the establishments under the Director General of Quality Assurance to trade firms on payment against Director General of Supplies and Disposals tender enquiries or contract in respect of defence stores or in connection with local' direct purchase made by Defence establishments under their Local Direct Purchase Powers. Where classified Specifications' Drawings are involved these will be supplied to successful Tenderens only on payment of hire charges The charge hire charges will be us specified in para Labove
- 4. In case of classified Specifications Drawings required by civil Central 'State Government Departments (including Govt Undertakings' Enterprises) for their departmental use. one set will be issued live of charge.
- 5 Any additional set required will be supplied on payment as per charges indicated in para I above. Specifications. Drawings of classified nature will not he issued as a rule
- 6. The amount realised on account of sale and issue of specifications' drawings on hire charges will be credited to the Govt under the Major Head 0076 Misc receipt Code 420/3 Minor 108' Inspection Organisation of the Defence Services Intimates.
- 7. The orders shall have effect for a period of Two years from the date of issue of this letter. Thereafter the contents of this letter will be reviewed. However these rates will continue to be applicable till this letter is superseded by a fresh Govt Letter.
