

With regard to fixation of pay on grant of financial upgradation under MACP Scheme, an individual may exercise option under FR22 (I) (a) (i) to get their pay fixed in the level in the pay matrix as per provisions of 7<sup>th</sup> CPC. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS.
4. The above financial upgradation will be further subject to the terms and conditions issued by DoP&T from time to time on the subject of Modified Assured Career Progression Scheme.
