

As per directions contained in DoP&T OM No. 36012/11/2016-Estt(Res-I){Pt-II} dated 15 Jun 2018, promotions based upon above panels shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP(C) No. 30621/2011 and various other SLPs on the subject matter. The promotion orders based on above panels must clearly mention this stipulation.

3. The above promotion panels shall remain operative for a period of one year unless exhausted earlier or specifically extended. Promotion/transfer orders from the panels will be issued by the HQ DGQA(Adm-6A) separately subject to availability of vacancies.

4. The seniority of the empanelled officers on promotion to the post of AO (Except Sl. No. 1,5,6,7,9,16,17,18,19,20,21,22,24,27 & 28, since these officers already retired from service) and to the post of SO (Except Sl. No. 1 since officer already retired from service) will be fixed in the order their names appear in the promotion panel.
