- 5. In case an official refuses to accept promotion, his unconditional unwillingness for the same and reasons thereof should be obtained in writing and forwarded to DGQA/Adm-6A within 10 days of receipt of this order, through the concerned Head of Estt with due recommendation of respective ADGsQA/Offg ADGsQA for our further action. No representation for change in the place of posting shall be entertained.
- 6. The reason for forgo promotion should invariably be on a very valuable/compelling grounds alongwith relevant documents to support the ground given by the official with due recommendations of concerned HoEs and their respective ADGsQA/Offg ADGsQA. In case where the reason(s) adduced by the officer for his refusal for promotion are not acceptable to the Appointing Authority, the Appointing Authority may enforce the promotion of the officer and in case the officer still refuses to accept the promotion, then disciplinary action can be taken against him for refusing to obey the orders as per Rules in vogue.
- 7. Action on initiation / endorsement of APAR/NIR/NIC, if due, will be completed in compliance to the extant policies and a confirmation regarding the same should be forwarded to HQ DGQA/APAR Cell by the concerned HoEs.
- The officers are entitled to TA/DA and joining time, as admissible.
- 9. The officers will exercise their option for fixation of pay on promotion, within one month from the date of promotion, as per CCS (Revised pay) Rules, 2008.
