

2. The above financial upgradations under ACP/MACP Scheme shall be purely personal to the individuals and shall have no relevance to their seniority position.
3. The above up-gradation will be further subject to the terms and conditions issued by DoP&T from time to time on the subject of ACPS/MACPS.
4. In case of Draughtsman cadre employees the financial upgradation under ACPS/MACPS has been granted ignoring their promotion/placement from the post of Tracer to the post of Draughtsman Grade III as per implementation of the Hon'ble CAT(PB), New Delhi order dated 03 Apr 2013 in OA No. 2520/2012. Hence, the 3<sup>rd</sup> financial upgradation under MACPS granted, if any, in the past to the above mentioned Draughtsman cadre employees in the Grade Pay Rs 4600/- are to be treated as cancelled.
5. Before granting pay fixation benefits under ACPS/MACPS to those individuals above whose date of admissibility is after the issue of this letter, Establishments will ensure that no Vigilance/disciplinary case is either pending or contemplated against them on due date of financial up-gradation.
6. Necessary action may be taken by concerned establishments to publish DO Part-II Order for information of their staff.
