**POSTINGS / TRANSFERS OF OFFICERS (PSSO) OF ARMAMENT
DISCIPLINE UNDER ROTATIONAL TRANSFER SCHEME: 2021**

1. Refer: Posting/Transfer Policy in respect of Gp'A' (DQAS & PSSO Cadre) officers of DGQA as promulgated vide MOD OM No. 43(1)/D(QA)/DGQA /Adm-7B/2016 dt 24 Nov 2016 .
2. In view of para (9) of posting/transfer policy in respect of PSSO of DGQA , a list of officer completing the prescribed tenure as per para 2 and 6, under RTP by 30 Jun 2021 and station wise detail of vacancies are available at DGQA website as **Appendix 'A' & 'B'** respectively.
3. The PSSO due for RTS-2021 as per Appendix 'A' are required to submit preferences of his posting (minimum three station choices) through HoE within a period of one month from the date of issue of this letter.
4. At the time of submitting the three choices for posting, the following are to be kept in mind :-
 - (a) Officers who have not served at any hard station as mentioned in Para 5 of the Policy, are requested to forward one of choices from said Para.
 - (b) Estts located at one station will be treated as one choice only.
 - (c) Vacancy at a particular station may increase/decrease due to proposed restructuring of DGQA.
5. Cases for exemption from RTP as per para 10(c) and 10(d) and application for compassionate posting be forwarded separately with the recommendation of HoE within one month of issue of this letter. No application on these grounds will be entertained thereafter.
6. It should be noted by officers that merely giving choice of stations by officers under RTS will not ensure that they will be posted to one of three choice stations. The decision of posting station will be taken based on the following factors :-
 - (a) Previous service in a hard station/ peace station.
 - (b) Cumulative service already rendered in the choice stations.
 - (c) Residual service of the officer.
 - (d) Organizational interest.
 - (e) Any other relevant aspect not included above.

7. It is also requested that latest paramount card of officers due for RTS-21 may also be forwarded.
8. This has the approval of Offg ADGQA(A).
