**DELEGATION OF POWERS FOR  
TEMPORARY TRANSFER OF POSTS**

Sir,

In continuation of Min of Def letter No. C/85064/Ty.Trans/DGQA/Adm/RMD(PE)/916/D(QA)/10 dt 09 Aug 2010 the undersigned is directed to convey the sanction of the competent authority to the continuance of delegation of powers of Director General of Quality Assurance for temporary transfer of posts (Service and Civilians) (Group 'A', 'B' & 'C') within the Directorate General of Quality Assurance, subject to the following terms and conditions :-

- (a) Powers for temporary transfer of posts shall be exercised not more than twice during a calendar year.
- (b) Proposals of temporary transfer of posts will be vetted by a Standing Review Committee set up by DGQA for this purpose, consisting of Spl DGQA (Chairman) and ADGsQA concerned before these are approved by DGQA. In absence of Spl DGQA, due to death or long leave or post being vacant, ADGQA(Adm) will be Chairman of the Committee.
- (c) Temporary transfer of posts will be confined to sanctioned establishments of DGQA Organisation. There will be no creation of additional posts or surrender of any posts.
- (d) The exercise of temporarily increasing the PEs, in addition to being done only twice a year, should be confined to enhancement of PEs not exceeding ten in number, the corresponding changes in these PEs being considered as incidental.

(e) The enhancement in PE should be done only in the case of those units which are linked to such of those production establishment which are connected with the induction of

- (i) new stores
- (ii) where new overhaul facility has been created.

(f) The power would exist only to transfer posts within the discipline from PE, where work is less, to PE where work is more, on the basis of assessed workload.


(g) DGQA shall exercise, the powers w.r.t. Group 'A' Officers only for Lt Col/Col or equivalent rank officers. The post of Maj Gen or equivalent, Brig or equivalent will not be transferred.

(h) Group 'D' post will not be transferred.

2. Delegation of the powers to DGQA in this regard will be valid for a period of three years with effect from 21 Dec 2012 and a review would be conducted after the expiry of this validity period.

3. This issues with the concurrence of Min of Def (Fin) vide their Dy No. 163/IF(DS)/3 dated 05 Apr 2013.
