Those officials who will be completing their tenure on 30 Jun 2023 shall join the new duty station **by 10 Jul 2023**.

6. In case an official does not report at the new establishment/unit within the stipulated time, the same will be treated as 'unauthorized absence.' The official concerned shall be liable for disciplinary action for the charge of lack of devotion to duty and conduct unbecoming of Govt. Servant.
