- 3. The officers will exercise their option for fixation of pay on promotion as per FR 22(I)(a)(1) within one month from the date of assumption of charge of SAO-II.
- 4. The officers may be relieved of their duties and directed to report to their new establishments immediately, and in no case later than one month from the date of issue of this order. The order of promotion will be effective from the date of assumption of charge of the higher appointment as SAO-II. No request for change in place of posting would be entertained.
