- 4. Before the abovementioned individuals assume higher appointment, it may be ensured that no disciplinary case is pending against them.
- 5. The individuals promoted as Office Superintendent will remain on probation for a period of two years from the date of assumption of charge in the post of OS.
- 6. The individuals will exercise option for fixation of pay on promotion within one month from the date of promotion as per FR-22-1(a)(i) except those who are already in the higher pay scale granted under MACP scheme.
- 7. As per directions contained in DoP&T OM No. 36012/11/2016-Estt. (Res-I) (Pt-II) dated 15 Jun 2018, promotions are subject to further orders which may be passed by the Hon'ble Supreme Court in SLP (c) No. 36021/2011 and various other SLPs on the subject matter.
- 8. Completion report should be sent to this HQ (DGQA/Adm-10) by 12 May 2023.
