
GRANT OF FINANCIAL UPGRADATION UNDER MACPS:

2. The above financial upgradations under MACP Scheme shall be purely personal to the individuals and shall have no relevance to their seniority position.


3. The above upgradation will be further subject to the terms and conditions issued by DoP&T from time to time on the subject of MACPS.
