

- As per Ministry of Finance OM No. 5(59)-E.III/B2 dated 13.03.1984 (circulated vide Min of Defence ID No. 12(1)/84/D (Civ-I) dated 03.07.1984), revised scales of pay allowed to the Draughtsmen Grade I, II & III of CPWD were extended to Draughtsmen Grade I, II & III in Defence Establishments subject to the condition that their recruitment qualifications are similar to those prescribed in the case of Draughtsmen in CPWD.
- Consequent to the issue of Ministry of Defence letter dated 15 Sep 1995, it was observed that the benefit of revised pay scale was not given to those Draughtsmen of DGQA, who were appointed between 15 Sep 1995 and 20 Sep 1999 with the same qualification as for those Draughtsmen appointed before 15 Sep 1995 with the qualification of Diploma in Engineering with one year experience in the relevant field:

Draughtsmen appointed before 15 Sep 1995 with the qualification of Diploma in Engineering with one year experience in relevant field as per RRs were given the benefit of revised pay scale on the analogy that they satisfied the qualification criteria of Certificate/ Diploma of minimum 2 years as stipulated in the Ministry of Defence letter dated 15 Sep 1995. Since the Draughtsmen were appointed between the period 15 Sep 1995 and 20 Sep 1999 with the same set of RRs, giving a different treatment to the appointment made prior to 15 Sep 1995 and after 15 Sep 1995 with the same set of RRs appeared to be anomalous.

- In order to bring about uniformity in application of revised pay scale to Draughtsmen appointed between the period 15 Sep 1995 and 20 Sep 1999, sanction of the Competent Authority is hereby accorded for extension of provisions of Ministry of Defence letter No. 1(6)/94/D (Civ-I) dated 15 Sep 1995 by granting higher pay scale to Draughtsmen of DGQA, who were recruited during 15 Sep 1995 to 20 Sep 1999 with qualification of Diploma in Engineering with one year experience in the relevant field.
