- 4. It is submitted deliberation has been done by Offg ADGQA(L) with DG, DGQA, and the following have to be implemented:-
 - (a) No SQAE will be independent, but will form part of either Controllerate or of RQAE.
 - (b) HQ DQA(L) with PEC will be separate from SDCC with STL.(Para 3 (a))
 - (c) Hence, SDCC with STL will have its own PE with SUS number of SQAE(L) New Delhi.(Para 3(b))
 - (d) SQAE(L) Bengaluru will be merged with CQA(L) Bengaluru and hence SQAE(L) Bengaluru PE is being listed under DQA(L) estt.(Para 3 (e))

- (e) SQAE(L) Secunderabad will be merged with CQA(EW) and hence combined PE forwarded (refer Para 3 (f)).
- (f) SQAE(L) Mumbai is re-designated as SQAE(L) Pune, with Wing at Mumbai (Para 3 (h)).
- (g) STL Secunderabad will be an independent estt with SUS of SQAE(S) Secunderbad and hence separate PE forwarded.(Para 3 (m))
- (h) Manpower for PECs and STLs have already been approved by DDP/MoD as part of ISAFE program of Govt. of India.
- (j) For all the SQAEs that are forming part of various RQAEs, the PEs have been forwarded as input to the RQAE PEs, as and when will be formulated by the appointed agencies.
- 5. Accordingly, Adm Dte is requested to change the Organization chart with due approval of DG, DGQA please.
- 6. Any changes required in the manpower authorization and footnotes may be consulted with HQ DQA(L) well before any decision is taken.
