**MINUTES OF 31ST ANNUAL MEETING OF THE GENERAL COUNCIL:
DGQA SPORTS CONTROL BOARD 2022-23**

1. The 31st annual Meeting of the General Council(AMGC) of DGQA Sports Control Board for the year 2022-23 was held at HQ DGQA, New Delhi, under the chairmanship of Lt Gen RK Malhotra, DG, DGQA, President DGQA Sports Control Board on 13 Jul 2022 at 1500 hrs onward. The list of attendees is attached as **Annexure 'A'**.
2. Commencing the meeting, Jt Secretary welcomed the President, Leader Staff side, Chairman of all Zones, DGQA Adventure Sports Cell and other Zonal Members of the DGQA Sports Control Board. The General Council has been informed that the last meeting i.e 30th AMGC of DGQA Sports Control Board was last held on 25 Jul 2019. It could not be held in subsequent years due to COVID-19.
3. Due to COVID-19 no sports activities were conducted in the year 2020 and 2021. In the meantime, the validity of previous Council members also expired on 31 Mar 2021. Accordingly, the President has re-constituted the General Council of DGQA Sports Control Board duly rotating the Chairman of every Zone as decided in the previous meeting, besides nominating new members for each zone.
4. Audit Report and Treasurer's Report for the financial year 2019-20 were presented. The General Council was apprised that audit report for the financial year 2020-21 is being finalized which will be shared with the General Council in due course. Since there were no sports activities during last two years there were no observer's points to discuss.

5. With the approval of the President the following sports activities have been earmarked to zone mentioned against each:-

6. The President directed to initiate atleast two sports activities viz. Volleyball and Badminton immediately. The concerned zone will submit the complete timeline of the events along with the financial implications to HQ DGQA for allotment. Spl DGQA, Vice President suggested that HQ DGQA should issue instructions in this regard immediately without waiting for issue of minutes of this meeting. The President approved this suggestion. Accordingly, a letter to concerned zone has been issued by this HQ vide letter No. C/85864/Meeting/DGQA/ADM/SCB dated 14 Jul 2022.

7. Capt AK Jindal and Sh. Denny Isaac, Leader Staff Side informed the President that DGQA employees under the aegis of DQA(Naval) were mostly unaware of such events being organised by DGQA Sports Control Board and to whom they should contact for organising the sports activities. Accordingly, the President directed all Zones to publicise sports events through all possible means of the communication including emails and DGQA Website with special emphasis to DQA(N) employees. Organisation of the sports activities is the responsibility of the Zonal Chairman.

8. With permission of the President, Leader Staff Side raised the following points for consideration of the Council members:-

(a) Zonal Chairman are not meeting with the members of the Zonal Council and not convening any meeting to discuss about any sports events. The President directed that all Zonal Chairman will convene meeting with members atleast once in six months. The President also directed that every Zone should be ready by 30 April of the financial year with detailed timeline and tentative financial implications about the sporting events to be conducted in the coming years. This will also facilitate the allotment of budget and financial planning.

(b) Participation of DGQA Sports person in sports of national/international importance is not allowed by the HoEs. The President though agreed for participation but emphatically stated that the office work should not be hampered due to over-involvement in sports activities. HoEs should decide the matter judiciously.

(c) **Honorarium was not given to all the Zonal Council:** Due to pandemic, no sports were conducted for the last two years. As such the practice of giving honorarium was interrupted. It is requested to restore the grant of Honorarium as being done on earlier occasions.

(d) **To Treat Ty Duty for participation in sports activities:** DoP&T orders for treating participation in National level tournaments as "duty" be considered.

9. Chairman, South Zone raised the point that after corporatization of Ordnance Factory Board, the ground and infrastructure facility, which were earlier provided free of cost by the Ordnance factories, are now being made available with certain amount of fees which may increase the usual budget for the sporting event. After deliberations on the matter with all the members it was decided that all the participants/teams would stay in close proximity of the venue. Zonal Chairman will be responsible for organising of the events. To adjust the financial burden, TA/DA provisions available to the participants may also be taken into consideration if required.

10. Since there were no points left to discuss, the meeting ended with vote of thanks to the Chair.
