
It has been observed different set of drills and procedures for QA activities is being followed in various Dtes/AHSP/Establishment of DGQA

- (b) Quality & Reliability Framework & Procedure for Design, Development, Production & Sustenance of Land System (QRAFP-DDPS-LS) (JSG 0829:2023).
- (c) QMS Manual (DGQA/STD/004-23).
